

# EXHIBIT "A" TO A DEED FROM SPIRIT OF THE MOUNTAINS CABINS, LLC, TO SPIRIT OF THE MOUNTAINS RETREAT, LLC

Being all of that certain tract of land containing 24.0 acres, more or less, which *encompasses* and combines into a single tract of land all of the following two parcels:

# PARCEL I:

Being all of that certain tract of land containing 23.0 acres, more or less, as shown on a plat entitled "Plat prepared of property owned by Charles M. Morgan" recorded in Plat File 8, Slide 816, Records of Plats for Transylvania County.

Being all of the same land described in a deed from Charles M. Morgan Co. to Jerry E. Thorsen and wife, Coral L. Thorsen, dated July 19, 2000, and recorded in the office of the Register of Deeds for Transylvania County in Document Book 19, page 70.

This conveyance is made subject to all of the special terms and conditions set out in the deed recorded in Document Book 19, page 70, hereinabove referred to.

### PARCEL II:

Being all of that certain tract of land containing 1.00 acres, more or less, as shown on a plat thereof recorded in Plat File 9, Slide 35, Records of Plats for Transylvania County.

Being all of the same land described in a deed from Myrtle H. Kriedt as Trustee, et al, to Jerry E. Thorsen and wife, Coral L. Thorsen, dated November 10, 2000, and recorded in the office of the Register of Deeds for Transylvania County in Document Book 37, page 23.

Together with a right of way to Crab Creek Road (NCSR 1528) over and along Morgan Drive as the same is now located and shown on the plats of Little River Ranch recorded in the office of the Register of Deeds for Transylvania County.

Being all of the same land described in a deed from Coral L. Thosen (a divorced and unremarried woman) to Spirit of the Mountains Cabins, LLC, a North Carolina limited liability company, dated December 18, 2008, and recorded in the office of the Register of Deeds for Transylvania County in Document Book 482, page 117.
